Current: General Population

- Adults 18 years & up



BRITISH COLUMBIA

Current: Phase 3

- Adults 59 years & up
- First Nations, Inuit and Metis 18 years & up
- Adults 40 years & up in high-transmission neighbourhoods
- People 16 years & up who are clinically extremely vulnerable
- AstraZeneca vaccine for adults 30 years old



ALBERTA

Current: Phase 2C

- Adults 65 years & up
- First Nations, Metis and Inuit 50 years & up
- Individuals 12 years & up with underlying health conditions
- Healthcare workers and other staff in patient care facilities
- Healthcare workers on First Nation reserves
- Shelter staff and residents
- Correctional facility and inmates
- Workers at meatpacking plants
- AstraZeneca vaccine for adults 40 years & up



SASKATCHEWAN

Current: Phase 2

- General population vaccination
- People with underlying health conditions that are clinically extremely vulnerable – priority sequencing, regardless of age
- Healthcare and frontline workers
- AstraZeneca vaccine for adults 42 years & up



MANITOBA

Current: Phase 1

- Adults 50 years & up
- Adults 18 years & up who live and work in eligible communities/health regions
- First Nations people 30 years & up
- Frontline police officers and firefighters
- Healthcare workers
- Workers in acute care, COVID-19 facilities, congregate living facilities, emergency, outpatient settings, personal care homes and laboratories.
- Vulnerable population
- AstraZeneca vaccine for adults 40 years & up



ONTARIO

Current: Phase 2

- Adults 55 years & up, starting April 30
- Adults living in COVID-19 hot spot communities
- Individuals with high-risk chronic conditions
- People in high-risk congregate settings
- Caregivers in select congregate care settings
- Essential frontline workers
- Essential caregivers
- Communities at greater risk
- AstraZeneca vaccine for adults 40 years & up



QUEBEC

Current: Phase 2

- Adults 50 years & up, starting April 30.
- Adults under 60 years who have a chronic illness
- Individuals with a physical disability, intellectual disability or disorder of autism spectrum
- Workers of the health community and targeted social workers
- Essential workers in environments at high risk of outbreaks
- Pregnant women.
- AstraZeneca vaccine for adults 45 years & up



NEWFOUNDLAND & LABRADOR

Current: Phase 2

- Adults 65 years & up
- Adults in remote or isolated Indigenous communities
- Individuals at congregate living settings
- First responders
- Individuals 16 years & up who are clinically extremely vulnerable
- Rotational workers
- Frontline healthcare and essential workers
- AstraZeneca vaccine for adults 55-64 years old



NEW BRUNSWICK

Current: Phase 2

- Adults 60 years & up
- First Nations 16 years & up
- First responders
- Healthcare workers and regulated allied healthcare professionals
- Individuals with complex medical conditions
- Adults 40 years & up with 3+ select chronic conditions
- Rotational workers
- Housebound individuals
- AstraZeneca vaccine for adults 55 years & up



NOVA SCOTIA

Current: Phase 2

- Adults 60 years & up
- Healthcare workers
- Individuals in congregate living settings
- Staff in hospitals who may come in contact with patients
- Residents who live in large group settings
- First responders
- Individuals 16 years & up who are clinically extremely vulnerable
- Rotational workers
- AstraZeneca vaccine for adults 55-64 years old



PRINCE EDWARD ISLAND

Current: Phase 2

- Adults 40 years & up
- Adults 18 years & up living in Indigenous communities
- Adults 16 years & up with underlying medical conditions
- Frontline workers 16 years & up
- Public and private sector healthcare workers
- Non-frontline healthcare workers needed to maintain healthcare system capacity
- AstraZeneca vaccine for adults 55 years & up



Canadian Restrictions by Jurisdiction– April 29, 2021



BRITISH COLUMBIA

- No indoor social gatherings.
- Outdoor social gatherings of up to 10 people.
- Indoor funerals, weddings and baptism limited to max. 10 people.
- In-person religious outdoor gatherings and Outdoor funerals up to 50 people.
- In-person religious indoor gatherings are prohibited.
- Retail businesses must establish capacity limits based on 5 square metres between each customer.
- Restaurants, pubs and bars are closed for indoor dining.



ALBERTA

- No Indoor social gatherings
- Outdoor social gatherings up to 10 people.
- Wedding ceremonies up to 10 people.
- Funeral services up to 20 people.
- Wedding and funeral receptions are prohibited.
- Places of worship limited to 15% fire code occupancy.
- Retail businesses and shopping malls at 15% capacity.
- Restaurants, pubs, bars, lounges and cafes are closed for indoor dining.



SASKATCHEWAN

- No indoor social gatherings.
- Outdoor gatherings up to 10 people.
- Places of worship up to 30 people.
- Restaurants may remain open, except in Regina and Area.
- Retail and personal services reduced to 50% capacity; large retail stores up to 25% capacity.



MANITOBA

- No indoor or outdoor gatherings in residence.
- Outdoor gatherings up to 10 people.
- Indoor gatherings in public up to 5 people.
- Funerals and weddings up to 10 people.
- Places of worship at 25% capacity or 10 people.
- Retail businesses and malls may open with capacity limits of up to 25% or 250 people,
- Restaurants and licensed premises at 50% capacity; outdoor dining up to 4 people per table.



ONTARIO

- Stay-at-home order is in effect for all of Ontario.
- No indoor or outdoor social gatherings.
- Indoor and outdoor weddings, funerals and other religious services up to 10 people.
- Non-essential retail stores may open for curbside pick and delivery only or by appointment.
- Grocery stores, convenience stores and pharmacies at 25% capacity.
- Restaurants, bars and other food and drink establishments are closed for indoor and outdoor dining.



QUEBEC

- Restrictions by zones.
- No indoor or outdoor social gatherings in residence.
- Restaurants open for in-person dining except in Red Zones.
- Funeral services and wedding ceremonies up to 25 people.
- Places of worship up to 100 people; 25 people in Red Zones.
- Businesses, stores and boutiques are open and must comply to curfew.
- Bars, taverns, and casinos are closed.



Canadian Restrictions by Jurisdiction– April 29, 2021



YUKON

- Unorganized social gatherings up to 10 people indoors and 50 people outdoors.
- Outdoors up to 50 people.
- Organized social gatherings up to 50 people indoors and 100 people outdoors
- Funerals and weddings up to 50 people indoors and 100 people outdoors.
- Restaurants are open for indoor dining at full capacity.
- Bars, pubs and lounges at 50% capacity.



NORTHWEST TERRITORIES

- Indoor social gatherings in residence up to 5 additional people (to a maximum of 10 persons in house).
- Indoor public events up to 25 people.
- Outdoor public events up to 50 people.
- Indoor funerals are prohibited.
- Small outdoor funeral or burial service is permitted with up to 50 people.
- Faith-based gatherings up to 25 people.
- Restaurants and bars may open for indoor dining up to 25 customer; Outdoor dining up to 50 people.



NUNAVUT

- Indoor gatherings up to household plus 15 people.
- *Arviat*: indoor gatherings restricted to household, plus 10 people.
- *Iqaluit and Kinngait*: indoor gatherings restricted to household, plus 5 additional people for emergencies only.
- *Arctic Bay, Clyde River, etc.*: Indoor gatherings restricted to household, plus 5 people.
- Outdoor gatherings up to 100 people.
- *Arviat*: Outdoor gatherings up to 50 people.
- *Iqaluit and Kinngait*: Outdoor gatherings up to 5 people.
- *Arctic Bay, Clyde River, etc.*: Outdoor gatherings up to 25 people.
- Restaurants can open at 50-60% capacity, with certain regions closed for indoor dining.
- Businesses may remain open, with certain regions closing non-essential.



NEWFOUNDLAND & LABRADOR

- Informal gatherings limited to Steady20 contacts.
- Formal gatherings run by a recognized business or organizations up to 50 people.
- Retail stores at 50% capacity.
- Restaurants, bars and lounges can reopen for indoor dining at 50% capacity.
- Entertainment facilities up to 50 people.
- Gyms and fitness facilities may reopen up to 50 people.



NOVA SCOTIA

- Indoor and outdoor gatherings limited to households.
- No in-person faith gatherings, wedding or funeral receptions.
- Restaurants are closed for in-person dining.
- Fitness and recreation facilities are closed.
- Non-essential retail stores are closed.
- Essential retail can remain open at 25% capacity.



NEW BRUNSWICK

- Formal and informal social gatherings are permitted.
- Steady15 contacts outside of household
- Indoor social gatherings with Steady10 contacts for Northwest Region.
- Outdoor social gatherings up to 50 people.
- Business, retails, restaurants are open.
- Entertainment centres at 50% capacity.
- Gyms, fitness centres, spas and salons can open under a COVID-19 operational plan.
- Faith venues and services at 50% capacity; Up to 50 people in Northwest Region.
- Funerals and weddings up to 25 people in Northwest Region.



PRINCE EDWARD ISLAND

- Households can have indoor or outdoor gatherings of up to 10 people.
- Indoor formal gatherings at 50% capacity.
- Outdoor informal and outdoor gatherings up to 50 people.
- Faith venues and services at 50% capacity.
- Restaurants and bars can remain open.
- Business and NGOs – essential and allowable services may open.
- Gyms and fitness facilities may operate under a COVID-19 operational plan.
